

Subject:- Report on looting, vandalism and burning of house, household items/assets.

Sir,

With reference to the above cited subject, I have the honour to report to you as follows.

1. That, I Demthang Haakip aged about 60 years, H/o Vahnem belonging to the Kuki tribe/community, a Schedule Tribe recognized under the Constitution India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention Atrocities) Act, 1989. and that, I am a permanent resident of Chahsad Avenue, P.O./P Porompat District, Manipur-795 Imphal East.
2. That, at about 3 am/pm on the 7 June 2023, a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun along with various state forces like Manipur Police Commando and Indian Reserve Battalion (IRB) attacked villages and in the process, they have looted, vandalized and torched my house.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs 1 Crore 85 thousand (Rupee One crore eighty five thousand,) only.
4. Fortunately, me and my family managed to escaped from these criminals who even tried to kill burn us alive, and now currently taking refuge at Mongkol Khopi ccpur.

In the given circumstances, I humbly pray you to kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And for which act of kindness, I shall always remain thankful to you and obliged.
