This unlawful attacked put me and my family members 1 male and 3 female in grave danger. Therefore, we had fled. We are currently taking refuge at
/ Relative's Residence at Rengkai AG Road

Total worth of value/s destroyed: Rs. 4 Crores 31 Lakhs and 60 K

I, therefore, seek your timely intervention and register FIR.
