I would like to state that on 4 May 2023 at/around 11:00 AM, Meitei Community who were suspected to be instigated by Valley-based Arambai Tenggol and Meitei Leepun vandalized/looted/burnt my properties and my Residence/Quarter/Rent located at Haokip Veng P.O / P.S. Porompat District Imphal East.

This unlawful attacked put me and my family members 2 male and 4 female in grave danger. Therefore, we had fled. We are currently taking refuge at Rengkai (Rent) / Relative's Residence

Total worth of value/s destroyed: 1 Crore and 50 Lakhs

I, therefore, seek your timely intervention and register FIR.
