Sub:- Complaint report of vandalizing, looting of properties and burning down of my house at Chassad Avenue, Imphal East, Manipur - regarding.

Sir/Ma'am,

I, T. Sheilam Haokip, Retd. Manipur Forest Service (MFS) having a permanent residence at Chassad Avenue, Nongpok-Ingkhol, Imphal East District under **Porompat Police Station**, Imphal, Manipur would like to state the following few lines for your kind perusal and necessary action.

That, since 3rd May, 2023 night communal persecution swept across Imphal and parts of Manipur leading to a grave loss of life and widespread destruction of personal and public properties. Entire villages including homes and places of worship were burnt and razed to the ground. Till 05.05.2023 I, along with my family of 5 members were staying at Quarter No. 7/Type-V (CP), Lamphel, Imphal West-795 004, allotted in the name of my wife Ms. Alhing Haokip, Associate Prof. and HoD, Economics Deptt., DM College of Arts, DM University Imphal, Manipur.

That, on the 4th May, 2023, my house situated at Chassad Avenue, Imphal East, a stone throw distance north of Chief Secretary's Quarters and Director General of Police's residence was ransacked, looted and set ablaze to ashes by the Meitei mob, suspected to be members of Arambai Tenggol, Meitei Leepun and others.

Apart from this loss we have been traumatized due to the ethnic cleansing drive and complete breakdown of law and order in our State, Manipur. As there was no security arrangement from Imphal to hill districts, our family rushed to the Airport and fled to Guwahati on 06.05.2023 and took shelter here for now.

I, therefore, request you for registration of a **Zero FIR** as we cannot return to our home town to lodge a complaint due to the prevailing law and order situation in Manipur.
