Subject:- Report on Unlawful Displacement, Criminal Intimidation, Attempt to murder.

Sir,

I, the undersigned, have the honour to state the following for your kind intervention and favourable action praying for registering an FIR and investigate the matter by due process of law:

1. That, I Dr. (Mrs) Lalthangmoi Hmar W/o Dr Nabarum Moitra, belonging to the Hmar tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989.**
2. That, I am a permanent resident of Maring Land, Nongpok Ingkhoil P.O./P.S. Porompat, Imphal East, Manipur-795005, currently taking refuge at Sielmat, P.O., P.S. & District Churachandpur, Manipur-795128.
3. That, at about 04:00 pm on the 4<sup>th</sup> of May, 2023, some armed radical mobs belonging to meitei/meitei community spearheaded by Arambai Tengol and Meitei Leepun armed with sophisticated weapons, chanting anti-tribal slogan, charged upon the netizen at the above named locality mainly targetting the tribal populace with an intent to kill, bodily harm/injury and intent to destroy property, In the process, fearing for my life and security leaving all my properties/assets from my residential home, I flee and take refuge at my friends' place @ Maring land, on the 5<sup>th</sup> of may, 2023, for a period of two consecutive days.
4. That, however due to the deterioration of Law and Order situation @ greater Imphal areas, and for the sake of my friends' safety since harboring me and my family they were against the whim and are being targeted by the said miscreant, by reason of which we were compel to seek security escort from central forces with their help we were being escorted to Imphal
