In that, one person who was holding a rifle and aimed/target to an unknown mistry with an intent to kill the unknown person was spotted at Khurai Chingangbam Leirak. Immediately, our CDO personnel warn the man to halt and surrender the weapon. As he denied, our CDO personal chased the man and overpowered him near the Meira Shang of Khurai Chingangbam Leirak, Thangjam Leikai. Immediately, our CDO personnel took away the rifle from the said person and on verification; the detainee identified himself as one Soraisham Ibohanbi Singh (64 years) S/o (Late) S. Ningthemjao Singh of Khurai Thangjam Leikai Chingangbam Leirak, Porompat PS, Imphal East District.

So, the detainee was arrested from the spot i.e. Khurai Chingangbam Leirak, Thangjam Leikai near Meira Shang at 1:25 p.m. by observing due formalities and seized one .303 rifle bearing regd. no. 6120 L, having butt no. 296 loaded with four live rounds in the magazine and one live round in the chamber by observing necessary formalities at 1:30 p.m.

Therefore, the arrested person along with the seized arms and ammunitions are being handed over to you for taking up further necessary legal procedures against him.
