

Report.

In respect, I would like to report that I am the Proprietor of the Factory namely M/s Intext at Khurai Ahongei Leikai, PO -Lamlong, PS -Porompat and GSTIN - 14BJNPS2576N2ZE. The factory was opened at Charhajare, P.O. -Motbung, PS -G. Saparmeina PS, Kangpokpi and taken on Lease for 10(Ten) years owned by, Charhajare, P.O. -Motbung. As reported on the Sanatan Gorkha Sanskar Ghat, all the Structures and assets of the factory were destroyed by unknown armed Kuki miscreants on 6th May, 2023 at about 6:00 pm in the context of tension and violence between the two communities in Manipur since 3rd May, 2023.
