

With due respect, I am to bring your kind notice that, on 03/05/2023 at around 02:00 p.m. a group of unruly mob numbering about 200 to 300 persons belonging to Meitei community armed with deadly weapons like daos, iron rods, sticks, etc. attacked my rental house located at New Chekon, Imphal under Porompat Police Station. Luckily I could make a narrow escape leaving behind all my household properties, personal belongings and one two wheeler Yamaha Fascino bearing registration No. MN02G5172, Chasis No. ME1SED12BH0119803, Engine No. E3Y3E0295401.

I strongly suspect that, my household properties, personal belongings and my two wheeler which I left behind were burnt down/stolen by the unruly mob.

I, therefore, request you to kindly take strong actions against the perpetrators by registering as FIR/Zero FIR under relevant sections of the statutes of our country.
