Subject – **Report on vandalism and looting of house hold items.**

Madam,

I am to bring to your kind notice that I am a Scheduled Tribe, belonging to the Zou Tribe and a resident of New Lambulane, 1st Street, Opp. Tribal Market, P.O. & P.S- Porompat, Imphal East District, Manipur

That, on the 5th of June, 2023 at around 4.30p.m., my above said rented residence was attacked, destroyed and looted by a Group of Meeitei/Meitei radicals suspected to be members of the Arambai Tenggol and the Meitei Leepun. These groups are suspected to be patronized by the Chief Minister of Manipur, Shri. Biren Singh and the titular king of Manipur, Maharaja Leisemba Sanajaoba Singh.

The criminals broke open my gate, destroyed and looted every valuable property from my rented house. And properties worth Rs. **5,67,000.00** (Rupees Five Lakhs Sixty Seven Thousand only, were looted and destroyed in the process.

That, while carrying out their above said criminal activities, the said Meitei radical groups were shouting anti- tribal slogans like- "HAO HATLO", "KUKI HATLO", "KANGLEIPAK YAI PHARE", etc. Hence, the same can be taken as an insult on me and my family for being a tribal.

I, therefore, request you to kindly take strong actions against the perpetrators by **registering an FIR/ Zero FIR** under relevant sections of the statutes of our country.




