

Subject:- Request to register an FIR against the above mentioned accused for commission of offences punishable Under Section 153 (A), 200, 295 (A), 298, 505 (i), 120 (B) of the Indian Penal Court and other offences provided under the law.

PLACE OF OCCURRENCE AND DATE:-

The interview of the Accused with "Wire News Channel" committing the above offence was found out on 19th June, 2023 at place at Imphal East, Manipur under the Jurisdiction of the Porompat Police Station.

Sir.

- I. the undersigned would like to lay down few requests for your kind consideration and necessary action;
- 2. That the accused is stated to be a professor of Political Science, Hydrabad University.
- 3. That the accused during the month of June, 2023 has given interview in the channel "Wire news channel" with Karan Thapar regarding the current situation of Manipur which are very much defaming against the Meetei/Meitei Community and has also committed offence mentioned above.

- That the accused has stated in the above interview that "Secondly invoke religious sentiment of the majority in order to sacralize tribal land what is important here to noted in Chibu, for example, although the original inscription that was erected in the particular site which become controversia only three stone slabs in honour of the king, in honour of the then political and two general which was sent somehow when Chandrakiti Memorial Park inaugurated in October 22. Somehow Thanjing, God of Meiteis was impla there and it was seen as a kind of surreptitious encroachment on the tribal which is the serious way of snatching tribal land. And similarly in 2022 when similar attempts was (were) made to declare Koubru as the "Laipham" that seat of the principle God of the Meiteis, followed by the State to use religion, from the inner sword circuiting of procedural requirements that it follows both the cases". The statement made by the accused are all false and promotes the enmity between the different groups on grounds of religion and insulted the religious beliefs and religion. Further, his acts commits prejudic the maintenance of harmony of the State of Manipur and wounded the relig feeling of Meitei community in particular.
- 5. That the accused has stated in the above interview that "those responsibility violence should be dealt with under the law of the land. You cannot a lawlessness which in effect began to be adorned in Manipur by now. But think the major offensive strikes always come from the valley, raid tack in armed mobs who in fact work as instruments of Biren Singh government. It think this is unacceptable so long as this massive mobilization of armed mit group with full security cover by the Police Commando is allowed to wreak the on the tribal Villages, violence is not going to end." The very statement of accused is totally false and denied which are very much defaming against Meitei Community. The accused also gave statement that some controlled the present violence of Manipur are responsible for instigating the present violence.

which is totally false and denied and even more defaming to the Meitei community. The very statement of the Accused is reproduced here below for easy reference:

"The second point is that the Arambam (Arambai) Tengol and the Meitei Leepun continue to launch you know a mass scaled violent attacks against the Kukis in the foothills. They must be arrested; they must be you know prosecuted under relevant laws especially unlawful activities act and I think this is imperative ...there is also another important..."

The very statement of the accused has brought more communal enmity during this burning situation in the State of Manipur.

The statement made by the accused is misplaced and aimed at promoting hatred between the Meitei community and Kuki community. This Hon'ble Court may be pleased to appreciate the chronology of events as under:-

"I think this Narrative of the Kukis targeting the Meiteis is wrong. It if you look at clearly the pattern of violence since May 3rd, all conflagration happens because of the massive attacks, offensive attacks all these armed militant organizations who come off less to some frontal organizations.... the fear is...."

It is a well known fact that the present situation in the State of Manipurk started from the Churachandpur District after the rally turned violent on 3rd to 2023 as evident from the supporting documents. It is also a well known fact the present situation has been created by armed Kuki Militants against the State Government policies namely (i) crack down against illegal immigrants from Myanmar; (ii) large scale destruction of illegal poppy plantations in the differential hill districts including Churachandpur, (iii) war on illegal drugs declared by State Government; and (iv) eviction process against illegal encroachers inside

numerous but the reason stated by the accused No. 1 is only for demanding status of schedule tribe status by the Meitei community is completely false. The incumbent Chief Minister of Manipur, all these took different steps as stated above only to protect the interest of the indigenous people of Manipur (including the Kuki tribe who were settled officially in Manipur for over 100-200 years) and also in the interest of National security.

Therefore, the inflammatory statement of the accused that the Chief Minister has declared war on Kuki is destined to encourage the communal tension and killings of innocent Meiteis by the Kuki militants.

It is further respectfully submitted that at present the violence is cornered only with the killing of Meitei civilians and village defence force by the armed Kuki Militants. The very statement of the Accused No. 1 is very serious as it amounts to not only instigating the Kuki militants but also Kukis civilians to take up arms in their hands against the innocent Meiteis villages which is a very serious offence and as the result of the statement by both the accused many Kuki people all across the districts have started attacking and burning Meitei villages because of the inflammatory remarks of the separatist like the accused.

That the accused made many other allegations as mentioned in the above paragraphs which is causing further hatred, enmity and violence in between the Kuki militants and Kuki civilians on one hand; and innocent Meitei community, on the other hand. It is submitted that the peaceful coexistence which existed in the State between Meitei community and many Kuki people who have settled in Manipur for more than one-two centuries has been hijacked by these armed Kuki militants and illegal Kuki immigrants from Myanmar who have

recently come to Manipur in the last 30 to 40 years. That it worthwhile to submit here that during the regime of all the Governments in the State of Manipur, there were no process of identificable immigrants, prosecution against large scale destruction of cultivations, large scale seizure of narcotics substances, and eviction encroachments in forest area in the State of Manipur. It is only since the state of Manipur.

of March, 2017 that the present Government had started identifying the illegal immigrants from Myanmar and other countries, who are mostly labourers who were brought into the state of Manipur by big investors business man dealing with narcotic substances by the forming a huge cartel. Many leaders of the Kuki militants are the direct beneficiaries of these cartel and poppy is one of the main sources of terror funding of these Kuki terrorists who have mostly come from Myanmar. Therefore, large scale of destruction of poppy plantations in the hill ranges measuring over 8000 acre; seizure of narcotic substances during last five (5) years; crackdown against Myanmarese immigrants, eviction of encroachments in reserve forest areas are some of the main reasons as to why these Narco-terrorists are up in arms against State Government of Manipur and all these Narco-terrorists have been instigating the innocent Kuki community to attack against the Meitei villages located in foot hills and all other areas where Meiteis are minority across all Districts. Moreover, strict actions are being taken up by the present BJP led State Government against all the illegal encroachments in reserve and protected forest area across all communities including both the Meiteis/Kukis and also numerous actions have been taken against illegal constructions in Paddy Field stringently. These are also the main reasons which fueled the violence being instigated by the people with vested interest, as many illegal immigrants have started settling down in the reserve and protected forest areas of Manipur as a result of the military crack down in Myanmar during the last 3-4 decades. And the modus operandi of the illegal immigrants is that immediately after illegal settlements in interior part of forests, they will forthwith start poppy cultivations as a main source of livelihood under the finance and control of these Kuki militants.

It is also widely reported in the media that one of the Kuki Chin Ministers who was the Chairman of cabinet Sub-Committee for identifying the illegal Kuki immigrants from Myanmar along with his team visited Churachandpur District

International Border still remains porous and easily penetrable for illegal activities such as entering of illegal immigrants, illegal arms smuggling, illegal drug smuggling and such other anti-national activities.

8.2 Further, the Kuki National Army (KNA) has established in Myanmar since 1988 thereby demanding homeland for the kukis, and they were targeted by Myanmar Army and because of such reason they were even bombed and large number of them crossed the unfenced/open border and came to Manipur where they indulged in illegal activities in the Manipur's border region and beyond and also participated in drugs business, bringing of large number of illegal immigrants into the State etc. It is worth mentioning that the said KNA, KNO and other such illegal Kuki outfits operating in the Myanmar came easily through the porous border and gets easily mingled with Kuki citizens of Manipur residing in Churachandpur, Kangpokpi, Tengnoupal etc. since many of them belong to the umbrella of Kuki-Chin community, and the said community is residing largely in Myanmar, Bangladesh and India they are found in Manipur and Mizoram. Hence, after 1988 the North-East especially Manipur become a breeding ground for such illegal armed outfits after 1990s.

Another, threat to the State is demand for a Kuki homeland which can relates back about 20 years and it is worth mentioning that in Manipur most of these armed Kuki militants were formed to counter the counter part of Naga community after the Kuki-Naga Clashes in 1993-1994 but now due to all these selfish ideologies they have started demanding for separate State/UT or otherwise 'Kuki land or Zale'n-gam.

Zale'n-gam is one of the major ideologies shared by most of the separatist Kuki-chin militants who instigate innocent people belonging to Kuki-chin-zo community to demand for a single country which comprises of different pan Myanmar, Bangladesh, Mizoram, some part Manipur, Nagaland etc. And instigation and propagation of both the accused which is prima-facie approximate for the cause of Zale'n-gam creates a serious doubt the unholy nexus between both the accused and the armed Kuki militants are such their involvement in anti-national activities cannot be ruled out and its be investigated.

- 8.3 That the opium/poppy is the key source for many narcotics, inclin morphine, codeine, and heroin. And, since 1972 it has been widely planted; Hill Areas of Manipur especially in the Kuki dominated areas.
- has been prosecuted by the State Government under the law of the land for large scale plantation of Poppy in hill areas, clearing of large trace. Reserve/Protected Forest for poppy plantation, settlement of immigration foreign countries etc. But, the fact is that the Government of Manipur has serious actions under the ND&PS Act and such related legislations prosecuted everyone who has infringed the law of the land regarded community affiliations and without differentiating caste, creed or religion against those persons who are part of the poppy plantations, forest encroaches and such illegalities. Hence, the allegation of targeting Kuki communities that Government is baseless and wrong. It is also reported in the newspapers that destruction of illegal poppy planation is carried out all our state of Manipur and the same is not confined only to a specified at

present case but they refused to provide us the detail. Therefore, the complainants crave leave of this Hon'ble Court to direct the State authorities to disclose the correct documents and the police may seize the same as part of the case record in the interest of justice.

- 9. That from the Right to Information reply issued by the concerned authority, the mother namely Haulkhannem W/o Zelzakap, of the accused was enrolled for the first in the year 2005 in the electoral roll of 58-Churachandpur (ST) Assembly Constituency Roll-2005, when she was 57 years and the accused too in the years 2005 when he was 27 years. There is no mentioned of the father of the accused. The other family members of the accused namely Tualkhanlal and Thangkhanlain, their names also appears for the first time in the year, 2005 in the above electoral Roll. As such, the burden of proof of being Indian lies to the accused as well as his family members as provided under Section 9 of the Foreigners Act, 1946.
- 10. That the accused has stated in his interview with Wire news channel that "You see we have complete geographical as well as demographic separation now. It is difficult to imagine that Meiteis coming up to the hills or for that matter the Kukis going down to the valleys because they'll be hounded and they'll be killed. It is not just possible to think about coexistence within a particular political framework" which are totally false and denied and the allegations have been made to promote enmity between different communities on the false allegations and it has been made to divide the state. Therefore, with the above statements the accused has instigated the innocent Kuki people to hate all Meiteis including the Hon'ble Chief Minister in order to encourage the fighting, burning of Meitei Villages, and at the same time these statements clearly instigate to Kuki militant groups to hate and attack the Meitei villages and also all officials of State Government (including Manipur Police Personnel) who belong to Meitei community. It is just meant to see that Manipur continues to blood shed because

- 13. That the accused is known about the above facts but they have given and fabricated statements with their criminal conspiracy thereby committee offences under Section 153A, 200, 295A, 298, 505(1), 120B of the Indian Code, and others.
- 14. That it is highly suspected by general public that a large consinvolving the accused and as such his CDR (Called Detail Report) since 15 2023 to 18th June, 2023 is urgently required and the same may be set

following due process of law. .

In the light of the above mentioned facts and circumstances, it is therefore requested to kindly book the above mentioned accused under Section 153A, 200, 295A, 298, 505(1), 120B of the Indian Penal Code, for ends of justice.
