No. 05106802 Loitam Arunta Singh (38) yrs of 5th MR Khongjarol, Tamenglong attached with CDO Unit, Thoubal, presently posted at CDO Unit, Jiribam (Juliet - 80) and one unknown person lying death on the ground with pool of blood suspected to be bullet injuries. On enquiry, it has been ascertained that the unknown person was shot dead by Rfn. No. 05106802 Loitam Arunta Singh (38) yrs of 5th MR Khongiarol, Tamenglong attached with CDO Unit, Thoubal, presently posted at CDO Unit, Jiribam (Juliet - 80) from the service AK 47 rifle held by him. The unknown deceased was identified as Oinam Gandhi Singh (32yrs.) S/o O. Mohon Singh of Charangpat Bengi Mamang Leikai, Thoubal District, Manipur as identified by CD No. 10D0968 Oinam Sanatomba Singh (42) yrs S/O (L) O.
