Sir,

I, the undersigned, would like to submit the following few lines in the above referred subject for your kind perusal and necessary affirmative action. That on 01/09/2023, I paid an amount of Rs 3,00,000/- (Three Lakhs) only through RTGS money transfer in SBI Porompat Branch to one Ajay Bahadur Singh (38) yrs S/o (L) Subh Narayan Singh, Proprietor of Sanitary Hardware Store, Ganeshguri, Dr. R.P. Road Gopal Boro High School, Dispur, Assam, Sachivalaya Kamrup Metro Assam, 781006 as an advance for purchasing construction materials (TMT bars) for the use of my house building. The total amount was transferred to his Canara Bank Account No. 110121013809. RTGS UTR No. SBIINR52023090169760218 of the said transaction is enclosed herewith.

That, the said Ajay Bahadur Singh had assured me that he would get delivered the TMT bars (iron rods) to my address within 5/6/days. However, neither he send the materials nor refunded the said money which was sent to his account till date.

On repeated calls, he used many abusive languages which is beyond a bearable limit for a woman, using harsh words without any professional ethics or businesses manlike attitude. He even insulted the whole state of Manipur with words like "What you people in hilly areas of Manipur know about us", "Do whatever you want, I'll never send your material nor money". "File FIR, send whole relatives or all the people, I won't give your material or money".

As a result of it, all my works stopped. I couldn't concentrate on any of my basic works. I've been calling him continuously to get back my money, but all I receive is a daily dose of insulting, harsh & rough words. Such disrespectful words in high tone, derogatory remarks & verbal abuse give me lot of mental tension. I suffered from anxiety & mental depression because of it. I even thought of committing suicide as the money was borrowed at a landed interest & I have to continuously pay the interest. Besides, I being a person who respects hard earned labour, earned respectfully is being given a lot of mental harassment by his dishonest, cheating & abusive attitude towards a woman.

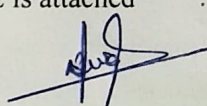

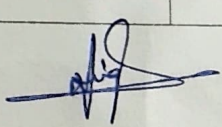
