This unfortunate incident hampered and lost all my belongings and properties about 8,25,600 (Eight lakhs Twenty Five Thousand Six Hundred) only . A tentative list of my personal properties is enclosed herewith.

I, the complainer, have been posted as an Lecturer in the Department of Anthropology, at Moreh College, for the last 19 years. My employee identification No (EIN) is 110897 under the Department of University and Higher Education, Government of Manipur (Copy enclosed).

I, therefore, would like to kindly request your good self to register this complaint as an F.I.R.

I shall be extremely thankful for your kind cooperation in this matter.

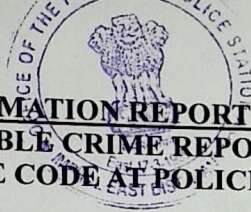




