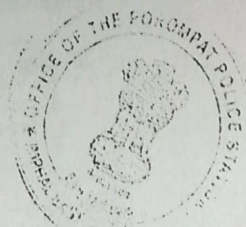

Subject: Report against the looting of my properties from DDK Staff Quarter No. C-47, Porompat, Imphal East, Manipur.

Sir,

I would like to lodge an FIR regarding looting of my household properties kept in DDK Staff Quarter C-47, Porompat, Imphal East, Manipur on the 16<sup>th</sup> of October 2023 around 8AM.

That sir, due to law and order situation that erupted on 3<sup>rd</sup> May 2023, my family along with several families belonging to Kuki-Zo communities were transported to IGAR South, Mantri Pukhri, Imphal by the Indian Army suddenly on 6<sup>th</sup> May 2023 at around 2PM leaving behind all our household items and properties in the quarters.

Unfortunately, I have come to know from our displaced group of DDK and AIR Imphal that on 16<sup>th</sup> October 2023, my quarter was looted by some miscreants. But I have not been able to report it until now as we are in Aizawl at the moment and just settling in.




