In the unfortunate incident, I have lost a total amount about Rs. 50,00,000/- (Rupees Fifty lakhs) Approx. . That, the incident was begin from 3/5/2023 . So, I and my all family members are staying at Wangkhei Thangjam Leikai. That, the incident was happen while I and my family were staying at Wangkhei Thangjam Leikai.

It is, therefore, requested to kindly take necessary legal action against the accused persons and the persons involved in the said inhuman acts and heinous crime according to law.

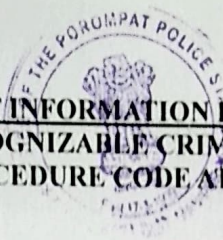


