With reference to SP Ukhul order no. C-1(G/P)/2024-SP(UKL)/518 Dated 19/01/2024, a combined team of Ukhul District Police, 6th MR, NAB and District Forest Department, led by Shri. Ringthing Hongchui, MPS, Addl.SP(Ops) Ukhul, under the supervision of Superintendent of Police, Ukhul, conducted destruction of illegal poppy cultivations at Sinakeithei hill range, about 26 km North-west from Litan Police Station, Latitude – 25.038862° N and Longitude – 94.144271° E on 20/01/2024 from 10:00 AM to 4:00 PM with attachment and destruction order of illegal poppy cultivation U/S 48 ND&PS Act, 1985 from SDO/LM Sub-division. An area of about 15 (fifteen) acres approximately was destroyed. It is expected to yield about 150 (one hundred fifty) Kg, 10(ten) kg per acre, worth Rs. 1,50,00,000/- (one crore and fifty lakhs only), Rs. 1 lakh per kg. None came forward to claim the ownership of the illicit poppy cultivated land. So, some poppy pods were seized for inducing evidence if required in the court of law and for taking further Legal necessary action.

Hence, a regular case on Suo-motu under FIR No. 1(1)2024 LTN – PS U/S 18(b) ND & PS Act, has been registered for Investigation.
