With due respect, I have the honour to state the following facts before you for favour of taking necessary action.

That on 3/5/2023 at around 5 pm a large number of miscreants suspected to be Arambai Tengol and Meetei Leepun forcefully attacked our permanent residential at New Lambulane, Nongpok Ingkhol, P.S Porompat, Impha-East District with an intend to murder by carrying sophisticated weapons.

As a result, they destroyed our house, looted our household items and later burnt down all our important documents. They destroyed and burnt down properties worth Rs 1.00 lakh. The residential plot of my land bearing Pucca Jamabandi No 26(A)/978 is estimated to be worth around 10 crores.

That the delay in reporting is due to lack of displacement and family sickness referred to supercialities healthcare outside the state.

Therefore, you are requested to kindly take necessary action at the earliest and for which act of kindness I shall remain ever grateful to you.
