

Subject: - First Information Report on the crimes of vandalism and arson attack on Public Properties at Chassad Avenue, Nongpok Ingkhol, P.S.- Porompat, Imphal East District, Manipur-795001. / Discrimination of Schedule Tribes.

Dear Madam,

With reference to the above cited subject, I, the undersigned, Head Deacon of Baptist Church, Chassad Avenue, Nongpok Ingkhol, P.S.- Porompat, Imphal East District, have the honour to report to you as follows:

1. That, we are Christians and we belong to the Kuki Baptist Convention (K.B.C.) and our Church i.e. Baptist Church: Chassad Avenue, is located at the above-mentioned location.
2. That, on the 4th of May, 2023, at about 9:30 AM, a huge contingent of armed radical Meitei/ Meeteis suspected to be members of Arambai Tengol and Meeitei Leepun attacked the above-mentioned location and in the process, they have looted, vandalized, destroyed and torched the following public properties, that includes:
 - a) Old Church Building (semi concrete)
 - b) 3(three) storied New Church Building (pucca concrete with Balcony)
 - c) Church Kitchen & Miscellaneous.
3. That, it may be reported here that the miscreants were shouting slogans like-"KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities. It may also be reported here that the above said criminal activities have caused grave mental agony to the church members and incurred huge loss which may be estimated to be worth Rs. 7,29,54,000/- (Rupees Seven Crores Twenty-Nine Lakhs Fifty-Four Thousand) only.

In the given circumstances, I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
