



Subject – Report on crimes of attempt to murder / unlawful displacement / vandalism,  
looting of properties and discrimination of Scheduled Tribes.

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I am a Scheduled Tribe belonging to the Vaiphei Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**.
2. That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our rented house owned by Kamminlun Gangte (8131920295) located at House No.63, New Lambulane, P.O./P.S.- Porompat, District- Imphal East- 795001 on the 3<sup>rd</sup> of May, 2023 at around 6:30 PM, And as a tenant renting a house belonging to a Gangte Tribe, I assume / suspect and also hearing from some unknown sources, that our deserted residence was attacked and looted by a Group of radical Meitei/ Meiteis suspected to be members of Arambai Tengol and Meetei Leepun, whereas the time and date remains unknown till date.
3. That, the deserted properties personal belongings is worth about **Rs.8,50,000 /- (Rupees Eight Lakhs Fifty Thousand) only**.
4. That, it may be reported here that the miscreants were shouting slogans in their Meitei/ Meiteis tongue like- **“LOVE LIVE MEEITEI LAND”**; **“KILL THE KUKIS”**; **“KILL THE SONS & DAUGHTERS OF THE KUKI TRIBES”**; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them,

even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.

I, therefore, request you to kindly register my case as **ZERO FIR** and take stern action against the perpetrators under the relevant provisions of the law of our country.
