



Dear Madam,

With due respect, I, Letsei Haokip age about 38 years s/o Thangkholum Haokip a permanent residence of HNo. 65, 1st Street New Lambulane, P.O. & P.S. Porompat, Imphal East would like to bring forth that after I, along with my family left our home for personal safety on the 25th June 2023 at around 1:00pm my house as mention above was torched and vandalized by a group of Meeitei Radical suspected to be led by Arambai Tengol and Meetei Leepun but the fire was drowsed after completely burning one room with all its furniture with the help of some Police on duty in that area.

And that, the loss in this arson is estimated to be at a value of about Rs.2,000,000/- (Rupees Twenty Lakhs only) which include of Household Furniture, electronic goods etc.

I therefore would like to request your kind office to take necessary action at the earliest.
