Road, Imphal East.

Dear Madam,

I, Thangliankhup Vaiphei Dy. Inspector General of Police, MPTO age about 57 years s/o (L) Damzakhai Vaiphei a residence of Maring Lane, New Chekon Road Near Bazar India P.O. Imphal & P.S. Porompat, Imphal East, presently staying at Red Cross Road Hill Town, P.O. & P.S. Churachandpur, Manipur would like to inform you that since the start of communal violence on the 3rd May 2023 I, along with my family took shelter in my office at 1st MR before fleeing to Delhi leaving our 2 storey house at the mention address with all our belonging in it.

That, on the 5th Day of August 2023 at around 6:00 pm some miscreant belief to be valley base militant storm into our localities attacking those houses and property belonging to the Kuki-Zo ethnic tribes by looting, vandalize and setting fire on it, burning down all our house and property just because we are Vaiphei (scheduled tribe) belonging to the Kuki-Zo community is atrocities against ST community.

That, this wanton attack on us has caused a lot of hurts and traumatize us mentally and also thereby causing physical loss of property which may amount to a monetary value of about Rs.35,000,000/- (Rupees Three Crore Fifty Lakhs only) including of Two Story RCC Building, state of art Kitchen appliances, furniture, Electronic Goods etc and some priceless ancestral property which may never be recovered again.

I, Therefore would like to request you to kindly take necessary action at the earliest for the end of justice.
