Sir,

I have the honour to report that today ie 20/12/2023 at about 8pm I along with team of Porompat PS were round patrolling duty in and around Checkon Tribal market area to maintain law and order in connection with present situation in the state. That, during round patrolling two persons were coming on the suspicious manner from New Lambulane side along with a bicycle, one gas cylinder and one TV immediately our team rushed and detained them for verification. On verification they identified themselves as 1. Md. Wahidur Rahaman aged about 20 years s/o Late Md. Azizur Rahaman of Minuthong Hafiz Hatta and 2. Md. Ayub khan aged about 29 years s/o Md. Abdul Jalil of Tarahei konjil Hiyangthang Imphal West. On further verification, they stated that the following articles mentioned have been stolen from a house at new Lambulane. So, the two detainee were arrested from the spot ie New Lambulane near Tribal Market and seized the articles from their possession.

It is, therefore, the two arrested accused persons along the seized article are handed over to you for further necessary legal action against them.
