The Management of the Private Security Agency, the Manipur Guard Services, takyelpat has already pulled up the suspected culprit and have dismissed him, without the consent of the Management of the City Convention Centre ( MUDA).

In this regard, I earnestly urge you to give permission to take appropriate action against the erring personnels and the agency and to make good the damaged done to the AC systems.
