I have the honour to state that a case involving the theft of air-duct for the outdoor units of the Air-Conditioning (AC) Units installed at terrace of the Block A have occurred on the evening of Wednesday, the 13th December, 2023 at the City Convention Centre, Imphal.

The incident have been reported on the afternoon of 14th December, 2023 (17.00Hrs) by the Head of the Private Security Personals deployed at the Convention Centre, Imphal.

As per report culled from the site, there is a strong possibility of the involvement of one of the Private Security Personnels, as some commotions were heard late in the evening of 13th December, 2023. On further investigation, it is revealed that the personnel involved is an active substance/drug addict. He hails from Sekmai, Imphal West District and is known by the name- Mr. Boboi..

The Management of the Private Security Agency, the Manipur Guard Services, takyelpat has already pulled up the suspected culprit and have dismissed him, without the consent of the Management of the City Convention Centre (MUDA).

In this regard, I earnestly urge you to give permission to take appropriate action against the erring personnels and the agency and to make good the damaged done to the AC systems.
