Sir,

With due respect, I would like to state the following for your kind information  
and necessary action:

That, due to the on-going conflict, we were compelled to flee our home located  
at my residential home at New Lambulane, 3<sup>rd</sup> Street Checkon, Imphal, Manipur on  
the 3<sup>th</sup> of May 2023.

Unfortunately, it is also learnt from reliable sources that all my household  
properties were ransacked, plundered and looted by unknown miscreants believed to be  
volunteers of Arambai Tenggol and Meitei Leepun on the 3<sup>rd</sup> of May 2023.

The estimated value of the properties lost, damaged or looted is about Rs.  
2,50,00,000/- (Rupees Two Crores and Fifty Lakhs).

In this regard, I would like to request your good office to take up necessary  
action so that I can be compensated, the culprits be caught and stringent exemplary  
punishment be meted upon them.


