Sir,

With due respect, I have the honour to state that on the fateful evening of the 3rd May, 2023 at around 5:30 pm, while my son namely Lalkhochon Baite (20) was reading in his rented room at New Lambulane, 3rd street at the resident of Mr. Thangjalam Touthang, he was beaten up along with the house owner and family by the Meetei Community suspected to be led by Arambai Tengol and Meetei Leepun. He was left to be dead. Fortunately, the local people (Kukis) arrived in time and brought him to Christian Hospital, Dewlahland, Imphal East where he was given first aid and his wounds stitched (head and leg) photo copy is enclosed for evidence. On 05/05/2023, he was admitted to Unit Hospital, 2nd M.R Bn. Further, on 08/05/2023 he reached Kangpokpi and admitted to RKS District Hospital, Kangpokpi. He had again admitted at Eden Medical Centre, Kashiram Road, Dimapur, Nagaland. Approximately Rs. 2,00,000/- (Two lakhs) has been spend till date. Delay of report to the P.S is due to his medical treatment and displacement/settlement.

I, therefore, request you to kindly take necessary action as per law of the land.
