Sir,

I have the honour to state that, On 04-05-2023 at around 11:30 am some unknown miscreant suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup Arambai Tenggol, numbering about 900-1000 forcefully attacked and entered our locality, Haoki Veng, Konung Mamang, Palace Compound Imphal East District, Manipur, about 45 Km South from Saikul-PS. The violent miscreants vandalised, destroyed and burnt down my garrage which is constructed inside my campus bearing C.S. Dag No. 4456 measuring an area of 0.03 Acre and 5418/(P) measuring about 0.019 Acre which is situated at Revenue village No. 83(A)- Palace compound, Unit-'B' Tahsil and Sub-Division-Porompat, Imphal East District, Manipur.

Fearing lost of life self alongwith my family left our house and fled to 1st MR Battalion and am now stayed at Saikul Relief camp.

The approximate value of the lost property including the land valuation is calculated at about Rs.90,000.00/- (Ninety lakhs).

It is, therefore, requested to kindly registered a regular case and take necessary legal action against the culprits according to law.
