

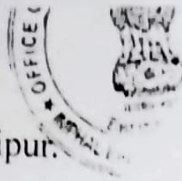

Sub: - Report regarding threat.

Sir,

With due respect and humble submission, I have the honour to draw your kind attention for your consideration and favorable action please,

That, some unknown armed miscreants believed to be some anti-social elements was following my vehicle very frequently while moving from my home to Clinic/workplace and other places suspiciously since July 2023. One unknown called and demanded me for a sum of amount Rs. 30,00,000/- as monetary aid regarding the present crisis followed by threatening me that if I fail to fulfill their demand then I will have to face dire consequences.

Subsequently, in the meantime suddenly on 26/12/2023 midnight four unknown persons by holding small arms entered forcefully into my Clinic(Smile Health and Dental Care) located Hatta opposite Oil Pump, Hatta and did gun pointed on my forehead, tied my hands at the back and eyes and dragged me on the floor attempting to murder that they will kill me if the monetary demand did not pay immediately. After few request, they laid me free but they snatched away my gold ring, apple ipad, and HP Laptop, a file containing all my personal original documents ie Certificates from X to Bachelor Degrees along with cash amount Rs. 1,08,000/-(one lakh and eight thousand) from inside my room after criminally trespassed. Further they shot one round of arm onto my Verna car at front portion and fled away quickly on taking advantage of the darkness. They had been given certain Demand letters multiples times and one of Demand letters is hereby enclosed. One empty bullet cartridge which they fired on my car was found in front of my car is also being handed over to you for further reference. As a result of which, my Verna car got bullet hole in the front portion. I would like to report to you regarding the said matter to help me by taking up necessary action please regarding for my safety.

So, it is therefore requested to take up necessary action against the culprits.
