With due respect, I would like to inform you that on 19th October 2023, suspected Meitei people have broken down the door of my abandoned house and looted all my valuable belonging that cost an amount of **Rs 15,09,636/- (Fifteen Lakhs nine thousand six hundred and thirty-six rupees)** from my house where I stay there as a tenant while the landlord is **Mr. Semlun Haokip**. Everything is looted and stolen from my house, which is located at **Mr. Semlun Haokip residence, 2nd Floor, 2nd Street, New Lambulane, Imphal, Manipur. Landmark – Opposite EIMI TIMES**. I was compelled to left my house on 4th May 2023 due to ethnic war between the Meitei and KUKI.

Therefore, I request you to look into the matter and file the F.I.R at your police station for further necessary actions that needed to be taken.
