

of my 2 (two) Homestead plot with building at 1st Street, New lambulane, Imphal.

Sir,

With due respect, I the undersigned would like to request you for favour of initiation and
necessary action on the above cited subject.

That, Sir, on account of the recent ethnic communal war that flared up from 3rd May, 2023 till
date. The condition of staying at the valley became unsafe and is becoming beyond dreams. As such
from fear of being kill or lynching fled from or left my house on 4th May, 2023 later shifted to 1st MR
Battaliomn and finally reached and took shelter as displaced person at Military Colony, Ward No. 7
Keithelmanbi, Kangpokpi District along with my tenants of my house.

That ever since from the 4th May onwards, I could not learn about my things that were left. Then
after a lapse of month I was informed by a reliable Muslim religious leader who is very intimate to me
that my house was raided in the dead of the night of 27th November, 2023 by valley miscreants robbed
and ransacked my room and lift off or robbed off my bed, fridge, furniture, household properties etc
which is about 9(Nine) lakhs worth.


As such, it is my appeal to your good office to look and take initiative of utmost protection to


