Most humble and respectfully, I would like to bring to your attention that we have left our house and our two stores one of which is a Flex Printing Centre and the other a Garment Store at Tribal Market Complex, New Lambulane, Imphal East on the 4th of April, 2023 due to the sudden outbreak of bloody ethnic conflict between Kuki and Meitei and eventually reached Kangpokpi District for my safety of life.

That, on 20/12/2023 received reliable information that some unknown miscreants had looted all my properties (Enclosed in the Annexure-1) from the two stores and my house by causing damaged and illegal trespassing into my house.

It is therefore, kindly requested to take necessary legal action to arrest the culprit involved in looting and damaged of my properties.
