I am submitting a complaint/report of robbery/theft in my house situated at 1<sup>st</sup> Street New Lambulane, Nongpok Ingkhol, House No 62 on Patta No. I/E-811, PO/PS-Porompat, Imphal East District, during my absence as we were out to Delhi for Medical treatment of my wife and my daughter on obvious reason.

The robbery/theft committed during the months of November & December, 2023 by the suspected Arambai cadre as they wearing black uniform as witnessed by some locals.

**The properties looted by the looters/robbers are as under:**

1. One (1) LG Fridge( big size) – Rs. 23,000/-
2. Two (2) King sized mattress – Rs. 70,000/-
3. Four (4) Gong including two (2) brass gong – Rs. 2,50,000/-
4. Modern and traditional garments - Rs. 80,000/-
5. Blankets and shawls – Rs. 60,000/-
6. Kitchen utensils – Rs. 90,000/-
7. Tap connections of 5 bathroom+ kitchen – Rs. 2,50,000/-
8. Two (2) Washing Machine – Rs. 55,000/-

The approximate amount of the looted properties is Rs. 8,78,000/- only.
