Sub: - Complaint/report of robbery and theft committed by unknown persons at my residential house.

Sir,

I am submitting a complaint/report of robbery/theft in my house situated at 1st Street New Lambulane, House No - 95, Patta No. Old-766, New- 961, Imphal East District, in the name of my son Lhunkholal Lupho, during my absence as we had left our house after the ethnic clash broke out on the 3rd May, 2023.

The robbery/theft committed during the month of December, 2023 by the suspected Arambai cadre as they were wearing black uniform as witnessed by some locals.

The properties looted by the looters/robbers are as under:

1. 2 Fridge – Rs. 50,000/-
2. 10 sleeping bed and mattresses – Rs. 1,80,000/-
3. Almirah godrej (3) and wooden (5) – Rs. 2,70,000/-
4. Two (2) Washing Machine – Rs. 35,000/-
5. Water pump (2) – Rs. 12,000/-
6. 2 Sofa set – Rs. 1,60,000/-
7. 1 television – Rs. 40,000/-
8. 2 nos of computer set with printer – Rs. 75,000/-
9. Kitchen utensils – Rs. 1,00,000/-
10. Traditional necklaces (4) and dresses – 1,60,000/-
11. Scooty Access regd. No.MN06SA - 8125- Rs.25,000/-
12. Sintex 5 nos – Rs 12,000/-
13. Other miscellaneous items – Rs. 90,000/-
14. Gas stove (2) nos and cylinder (4) Nos – Rs. 25,000/-

The approximate amount of the looted/ damaged properties is Rs. 12,34,000/- only.

Therefore, I requested you to take up necessary legal action against the culprits at the earliest time in the light of justice.
