

Sir

I have the honour to report that today i.e. 24/12/2023 at about 2:00 pm while I and my brother-in-law namely Kashung Ringo S/o Solomon Kashung of Nongdam Tangkhul were coming from Khuman Lampak to Nongdam Tangkhul near Maphou Dam on my brother-in-law's (Joram Keishing S/O (L) Seitingba Keishing of Nongdam (T) branch Awungtang) Maruti Swift car white in colour bearing registration No. MN01AG-1145, Chassis No. MBHCZC63SJK295418, Engine No. K12MN7369374 which was bought by my brother-in-law (Joram Keishing) from H. Henry Misao S/O H. M. Methang Misao of Motbung Village, Kangpokpi. On reaching Phouwabi bridge along NH-202 Imphal Ukhrul road a Maruti Suzuki Brezza car, white in colour without registration No. which was coming from behind suddenly overtook our vehicle and stopped in front of our vehicle. So, we also had to stop our vehicle. One person came out of the vehicle (Maruti Brezza) with a small arm. The person boarded our car and while pointing his gun at my abdomen ordered me to turn our vehicle around. As they were armed we followed his order and turned our vehicle around and took us to an unknown place. On reaching an unknown play ground they checked our Aadhaar card then they told us that our car belongs to Kuki community. Then they unloaded whatever things which were in our car and drove our car away to unknown direction. We were aware that this Maruti Brezza car was following our car from Khuman Lampak.

It is therefore requested to kindly take up necessary action to trace out our car and punish the culprits according to the law of the land.
