On 21<sup>st</sup> December, 2023 from a reliable source I have learnt that my house located at New Lambulane 1<sup>st</sup> Street, House No. 111, PO/PS-Porompat, Imphal East District has been ransacked and looted by unknown miscreants. The approximate loss properties worth Rs. 5,70,000/- (Five lakhs seventy thousands) only.

It is therefore requested you to take up a legal necessary action as per the law of the land.
