1. Laptop(HP) Worth 50,000/-
2. 1 (one) no. of Kitchen Almirah worth Rs.1,8000/-
3. One wooden bed box and medium size mattress and blanket worth Rs.40,000/-
4. Traditional shawl and cloths worth Rs.1,00,000/-
5. 1(one) Nos. of Gas stove and 2(two) Nos.of Gas cylinder worth Rs.50,000/-
6. Utensils worth Rs.50,000/-
7. Furniture (Table, Chair) Worth Rs.20,000/-

The total value of properties lost at my rented resident is about Rs.296,000/-(Two Lakh Ninety six Thousand)
