This is to bring to your information and necessary action that following the ethnic violence which erupted on the 3rd of May 2023, I have left behind my vehicles noted below:

1. NUVO Sport N8 (Mahindra), Registration no. MN02B4690, Colour - White, Engine no. SHG6J34540, Chassis no. MAIYG2SUXG2K36015, worth Rs. 12 lakhs, registered in the name of my wife, namely Vahneinieng.
2. Honda Activa, bearing Registration no. MN06SG8308, Colour - Black, Engine no. JK13EW1075249, Chassis no. ME4JK132KNW054083, worth Rs. 1,18,000/-, registered in the name of my son, namely Letgoulion Touthang at my house at New Lambulane, Link One Road, 1st Street in Imphal East, under Patta No. 407 H/N 122 while fleeing out of for safety.

On enquiring from a reliable source, it has been learnt that the said vehicles are no longer found and stolen away from where I kept, on 29th September 2023 at about 11am, by unknown persons.

I therefore request to kindly take up necessary legal action to recover my stolen vehicles and arrest the unknown culprits.

The cause of the delay in reporting on time is due to my displacement and lack of knowledge of procedures.
