Subject :- Report on Looting and burning down of household items/assets, and discrimination of Schedule Tribes.

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **Th Thangginlun** aged about 35 years S/o **Th Thanga** Belonging to the **Vaiphei Tribe / Community**, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a Resident of **New Checkon Road Near Ocean international. Imphal-East District Manipur. P.O., &P.S., Porompat.**
2. That at about **2:30 pm** on the **4th May 2023**, due to the ethnic violence in the state , my family and I have to run for our lives leaving behind our Rented house Owned by **Mr. Seiboi Singsitalong** with all our household items and belongings. and took shelter at **165 T.A Camp (Near Airport)**. And in the process some unknown miscreants have looted then burnt down our Rented house, including all our Household items and belongings including my two wheeler Activa (Red Colour) Bearing **Reg. No. MN02A7048**.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs.25,00,000/- (Rupees Twenty Five Lakhs) only**
4. Fortunately, my family and I managed to escaped from the Violence, and now currently taking refuge at **S Munnuam Village Churachandpur .**
5. That, I am filing this information lately because I was at different place And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
