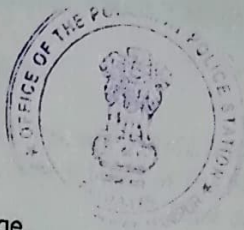

I have the honour to state that the undersigned, aged about 50 years, is an officer of the Manipur Civil Service and currently posted as Joint Secretary (Health & FW/TA & Hills), Government of Manipur. I am a resident of Near Officers Colony, Sanjenthong, Imphal. However, due to the current crisis in Manipur, I had to leave my residence on 4th May, 2023 and am currently displaced along with my family and attached at DC Office, Churachandpur due to safety reasons. I am presently residing in 104, A-1, Mini Secretariat Government Quarters, Tuibong, Churachandpur.

It has come to my knowledge that my abandoned house located in Near Officers Colony, Sanjenthong, Imphal has recently been broken into, ransacked and looted by unknown persons. List of items presumed to be looted is enclosed. Also, there is clear apprehension of illegal occupation of the house and its premises by unauthorized persons taking advantage of the situation.

Therefore, it is kindly requested that an FIR may be registered and urgent appropriate action taken to book the culprits. Necessary steps may kindly be taken to ensure the security of the house and also thwart any attempt of illegal occupation by unauthorized persons in due compliance of Hon'ble Supreme Court Orders dated 25-09-2023.
