Sir,

With reference to the above cited subject, I have the honour to make this report to you for your kind and favourable action please:

1. That, I, Shri Chalton Lien Amo aged about 68 years S/o (L) D.R. Thuoma Amo at present residing at C/o Lalthazam @ Lalthazam Amo 04, Nehru Marg, Lamka, P.O., P.S. & District Churachandpur, Manipur State belonging to the Hmar Tribe/ Community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am entitled to the protection under the SC/ST (Prevention of Atrocities) Act, 1989.
2. That, due to fear and intimidation by majority Meitei, our family run for our life and stay at CRPF Camp, Lamphelpat, our home/house situated at New Lambulane, bearing New Patta no: 1186, Dag No: 5412/5652 measuring an area of 0.061 acre of class Ingkhol, having village name 26(A) Nongpok Ingkhol, Imphal Municipality was looted as we left all our valuable goods and house hold items when the ethnic violence broke out between two communities i, e. on 3rd May 2023.

3. That, recently I came to know from some reliable source that our house was looted by some miscreants as we left behind all our household items and valuable assets inside our property/compound.
4. That, due to the ongoing ethnic cleansing spearhead by the majority meetei community comprising of Arambai Tengol, Meetei Leepun within the valley district, I had no option to make a report at a place where the incident occurred.
5. That, I couldn't make a report earlier as my wife and I were in Delhi and undergo Post-covid medical treatment and on top of that I got information about looting of my property only on the last week of December 2023.

In the given circumstances, I humbly pray to kindly register an FIR, investigate into the matter and punish the perpetrator as per the prevailing provisions/law of the country, and for this act of Kindness, I shall remain obliged and thankful.
