I have the honour to report that on 23/11/2023 at about 4:00 pm, I and the following persons namely 1. Hanjabam Ongbi Mema Devi aged about 58 years w/o Late. H. Arun Sharma, 2. Hanjabam Milin Sharma aged about 55 years s/o Late. H. Gosai Sharma 3. Hanjabam Smita Devi aged about 20 years d/o H. Milin Sharma, 4. Hanjabam ongbi Shanti Devi aged about 50 years w/o H. Memori Sharma all are residence of Wangkhei Ningthem Pukhrimapal near historical Park were assaulted black and blue by the following persons namely 1. Hidam ongbi Mala Devi aged about 58 years w/o H. Subol Singh Wangkhei Ningthemm Pukhri Mapal 2. Kongbrailatpam ongbi Nirmala Devi aged about 64 years w/o K. Binodbihari Sharma of Wangkhei Meihoubam Lampak 3. Hanjabam Ningol Sharmila Devi @ Moni aged about 53 years w/o Sapam Priyokumar Singh residence of Wangkhei Ningthem Pukhrimapal Leirak Machin and 4. Hanjabam Ningol Bharmala Devi aged about 59 years w/o Aribam Lokendro Sharma of Thoubal Okram by using wooden sticks and as well as kicking and pushing in connection with the land disputed at Wangkhei Ningthem Pukhrimapal near Hanjabam Mandop. As a result of which, I and the above victims received injuries on our persons and evacuated to Advance Hospital for medical treatment. I could not report the matter timely to your good office when we were taking medical treatment at the respective hospital and also the relevant medical documents are hereby enclosed for reference.

It is, therefore, requested to kindly take up necessary legal action against the above mentioned accused persons according to law.
