- That, I, Shri Lalthanzam @ Lalthanzam Amo aged about 72 years 5/o (L)
 D.R. Thuoma of 04, Nehru Marg, Lamka, P.O., P.S. & Distrct- Churachandpur, Manipur State belonging to the Hmar Tribe/ Community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am entitled to The protection under the SC/ST (Prevention of Atrocities) Act, 1989.
- 2. That, due to fear and intimidation by majority Meitei, our family abandoned our home/house situated at New Lambulane, bearing New Patta no: 1486, Dag No: 5412/5522 measuring an area of 0.061 acre of class Ingkhol, having village name 26(A) Nongpok, Imphal East District, Imphal Municipality, when the ethnic violence broke out between two communities i, e. on 3rd May 2023.
- That, recently I came to know from some reliable source that our house
 was looted by some miscreants as we left behind all our household items
 and valuable assets inside our property/compound.

- 4. That, due to the ongoing ethnic cleansing spearhead by the majority meeter community comprising of Arambai Tengol, Meeter Leepun within the valley district, I had no option to make a report at a place where the incident occurred.
- 5. That, I couldn't make a report earlier as my wife and I were in Mizoram and undergo medical treatment and on top of that I got information about looting and vandalization of my property only on the last week of December 2023 after we return back from Mizoram.

In the given circumstances, I humbly pray to kindly register an FIR, investigate into the matter and punish the perpetrator as per the prevailing provisions/law of the country. And for this act of kindness, I shall remain obliged and thankful.
