**Subject: Report for lodging Zero FIR case regarding looting and ransacking/burnt down of my house-cum-shop plots located at Moreh Ward No.4.**

Sir,

With due respect, I, the undersigned beg to report you the following few words for kind information and cause necessary actions,

That I am the permanent inhabitant of Soibam Leikai near Citizen Club, P.O. & P.S. Porompat. That I have also owned a plots measuring about 0.0120 Acre at Moreh Ward No.4 situated under Patta No. 435 (New) under C.S.Dag No. 3335 of Village No. 95-Moreh. That it was reliably learnt from various sources that in the midnight of 3<sup>th</sup> May, 2023 and 4<sup>th</sup> May, 2023, large number of innumerable unidentified groups of people suspected to be Kuki Community with deadly weapons and sophisticated arms storms to all the Meitei inhabitant areas of Moreh Ward No.4 and ransacked/burnt down the standing properties belonging to the Meitei Community one after another. In such incident, it has been informed that my house-cum-shop plot measuring about (30 breath X 35 Length) Sq.ft. situated under Patta No. 435 (New) under C.S.Dag No. 3335 of Village No. 95-Moreh recorded in my name have been vandalized/bunt down



and looted all valuables items including furniture etc. Now the said information of vandalized/burning down of my property is confirmed and there is no standing property left in the said patta Land. In that unfortunate criminal activities caused by unidentified mob, I have incurred huge lost which may be estimated to be Rs. 28,00,000/- (rupees Twenty eight lakhs) only for the building and Rs. 30,00,000/- (rupees thirty lakhs) only for the patta Land (**Patta Copy enclosed**)

In the given circumstances, I humbly pray you to kindly cause necessary actions for ends of justice by registering a ZERO FIR and punish the perpetrators as per the prevailing provision of laws of the land as early as possible.

For this act of your kindness, I shall always remain grateful to you
