First Information Report.

1. Input was received from credible sources at 290700H regarding illicit weapon and ammunition trafficking from Soma (Myanmar) Towards Ukhrul (Manipur). Based on the input active monitoring of all the routes from Soma to Ukhrul (via Tuzon and Poi) was carried out on 29 Aug 2023 at 1045 hrs one Kenbo was observed along route Soma (Myanmar) - BP-129 (RM-0955) - Tuzon (RM-0358) by our sub det. An MVCP along the route was activated at 291115H the MVCP checked the Kenbo Veh. 12 kg Gun powder (Approx. cost 26,500), Diamond selector machine and 03x Gem stones was recovered.

2. Details of recovered items:-

- ① Gun powder - 12 kg
- ② 02x mob with 02x sim card (02x Airtel)
- ③ Diamond stone - 03 Nos (40 gm - 01, 50 gm - 02)
- ④ Diamond Selector Type - 11 - 01 Nos.
- ⑤ Torch Light - 01 Nos
- ⑥ Kenbo Bike without Number plate.
