With due respect, I beg to state the following for your kind information and necessary action/order:

- That, I, Sangita Devi, W/O Subhash Prasad Sahu, am a resident of Mantripukhri, P.O. Mantripukhril & P.S. Heingang, Imphal East District-795002. Manipur.
- 2. That, I humbly beg to state that I am an account holder of National (Small) Saving Schemes of India Post (A/C. No. -010021427265, A/C. Name- Muskan Sahu, India Post- Mantripukhri Branch) and account type is Sukanya Samriddhi Account.
- 3. That, I am writing to you today to file a complaint against Lamnu Zou who is an employee of India Post (Mantripukhri Branch), who withdrawn Rs. 1,00,000/- (Rupees one lakh) only from my above mentioned account by fraudulently forging my signature. It is further submitted that I came to know about the said fraudulent transaction only on 03/06/2023 when I visited the post office to get a copy of the account statement. It was found that the aforesaid amount was withdrawn on 06/02/2023.
- 4. That, I humbly beg to submit that the act of this employee (Lamnu Zou) has caused me a great deal of financial loss and inconvenience. I contacted this employee (Lamnu Zou) on multiple occasions on her mobile phone no.- 6909108995 to resolve my issue but she always made false promises to me that she will deposit or she will refund/repay the said withdrawn amount to me on or before 15th day of June, 2023 but till now no fruitful result has been taken by her to resolve my complaint. I have multiple phone call recordings between my husband and Lamnu Zou for proving my point that she has withdrawn a sum of Rs. 1,00,000/- (Rupees one lakh0 from my above mentioned account without my knowledge and consent by fraudulently forging my signature and always making a false promised to refund/repay.
- 5. That, I am hereby attaching the following documents for your reference
- (a) Account Passbook (b) Account transaction statement.
- 6. That, I humbly beg to submit that the acts committed by the aforesaid Zou are punishable under various laws.

I under the circumstances mentioned above urge you to kindly register an FIR under relevant provisions of law as grave cognizable offence(s) have been committed and take appropriate action9s) subsequent thereto, at the earliest.
