With due respect, I have the honour to state that on 4th May, 2023 at around 5:00 pm in the evening unknown suspected to be Arambai Tenggol, Meeitei Leepun and Meira Paibis more than 300/400 peoples from the Meeitei community attacked my resident at New Checkon, Imphal East Sub-Division, Imphal East District, Manipur, looted and vandalized all my properties and burn down my resident to ashes.




