Subject:- Request for lodging FIR.

Sir,

With due respect, I have to state that on 28/05/2023 (Sunday) at around 3.10 am some unknown 50/60 suspected to be Kuki armed militants which are from nearby my village viz Urangpat Kuki, Gwaltabi Kuki and Molneljang Kuki village were coming to my mother house which is attached to my uncle house (Ashangbam Ibotombi Singh 58 yrs) located at Gwaltabi village. The unknown Kukis looted all the movable items of my mother house and causing damaged all my properties. Finally they burn down my uncle and mother Kacha house into ashes. The estimate value of causing damaged, looting and burning down properties and house is approximately 1,70,000/- (one lakh and seventy thousand).

It is requested to kindly take up legal action against the culprits.

I could not report in time as *violence* current communal clash and I was lodged at relief camp at Sawombung *on*.
