That sir, on account of the recent ethnic communal conflict that flared up between Kuki and Meitei community from 3<sup>rd</sup> May, 2023 till date, the condition of staying at the valley became unsafe for life and we fled from Imphal by leaving my house on 4th May, 2023. We were shifted to CRPF camp at Mantripukri and on 8th May, 2023, I along with my family members reached and took shelter as displaced person in one of my relative's houses at Kangpokpi Ward No. 2. Kangpokpi District.

That, ever since from 4th May, 2023 onwards, I could not learn about my things that were left and I could not made complaint to the police. However, recently on 24th December, 2023 I was informed by a reliable source that some unknown valley-based miscreants had trespassed into my house, damaged and looted/stolen my properties which includes washing machine, fridge, necklace, Drawer, Traditional Necklace, Gas cylinder 5 (five) nos, Dressing table, gold necklace, furniture, household properties etc which is estimated to be about Rs 10,00,000/- (Rupees Ten lakhs) only worth.

As such, it is my appeal to your good office to look and take initiative of utmost protection to the remaining things in my house for further theft and damages.
