I the undersigned have the honor to state that large group of people belonging to Meitei Community with deadly weapons and sophisticated arms including **ARAMBAI TENGGOL** groups stormed **GUNCHU COACHING CENTRE** and **LIBRARY (Regd. No. IE/4828 CE of 2023)** and **GUNCHU COMPUTER CENTRE (Regd. No. UDYAM-MN-04-0006459)** at Eden Tower (Patta no. 26(A) ; Nongpok Imphal:B57/1838), New Lambulane, Checkon, Imphal east under Porompat Police Station, on 29th of December (Friday) at around 2pm.

The said unidentified groups looted all my property. In that unfortunate incident, I have lost total amount of ₹ 96,45,600 (Ninety Six Lakhs Fouty Five Thousand and Six Hundred) .

It is therefore, prayed that the respected Sir may kindly initiate and take legal actions against the accused persons involved in the said inhuman acts and heinous crime committed by the persons as per law of the land as early as possible.

I shall be grateful for your kind cooperation and necessary actions.
