Then, after 3 months he contacted me and threatened me to hand over 30,000/- to him or else my nude photos and videos will be uploaded in social media. On 7th Nov. 2023 at @ 9.16 pm, while I was sleeping at my bed, he sent me my nude photos in my mobile No. through whatsapp and threatened me to send him Rs. 1,00,000/- or else he would upload the photos in social media. As such, Md. Abdul Kudus @ Amubi is threatening me every now and then. However, I could not report the matter timely due to lack of legal knowledge and afraid of him and the society.

I, therefore, request your goodself to kindly take necessary legal action against Md. Abdul Kudus @ Amubi.


